- RENTER - RESIDENTS - \$30.00 FAMILY POOL PASS IS REQUIRED FOR POOL USE – NO GUESTS ALLOWED - MUST SIGN IN TO ENTER POOL AREA**

THE GRANADA POOL EMPLOYEES ARE NOT BABYSITTERS –

THE GRANADA POOL STAFF PROVIDE PROTECTION, SAFETY & MAINTAIN THE POOL FOR THOSE ENJOYING THE POOL AREA.- THIS INCLUDES PREVENTING ANYONE THAT IS NOT A RESIDENT OF GRANADA OR DOES NOT HAVE A **CURRENT POOL PASS** FROM ENTERING THE POOL AREA WITHOUT PERMISSION – THIS IS FOR YOUR SAFETY

THE GRANADA POOL IS OPERATED & MAINTAINED FOR THE USE OF OWNER RESIDENTS ONLY – IF YOU ARE A RENTER – YOU MAY PURCHASE A PASS TO USE THE POOL - THIS PASS IS LIMITED TO YOUR IMMEDIATE HOUSEHOLD MEMBERS ONLY – NO GUESTS ALLOWED.

PROOF OF RESIDENCY MUST BE GIVEN AT THE TIME YOU APPLY FOR POOL PASS. SEE BELOW

- NO ONE **UNDER AGE 16 ALLOWED IN POOL AREA WITHOUT PARENT OR GUARDIAN** – SUBMIT COPIES OF DRIVERS LICENSE / STUDENT ID'S / MO. ID / OR BIRTH CERTIFICATE @ TIME OF OBTAINING POOL PASS.
- MONTHLY CONDO FEES MUST BE CURRENT** IN ORDER TO RECEIVE A POOL PASS OR SWIM.
- PROOF OF RESIDENCY IS REQUIRED WHEN YOU APPLY FOR PASS - SHOWING NAME & ADDRESS– I.E. – UTILITY BILL / DRIVERS LIC/ STUDENT ID / MO. I D - NO EXCEPTIONS**
- EACH PERSON MUST HAVE THEIR POOL PASS WITH THEM & SIGN IN TO BE PERMITTED IN THE POOL AREA.**
- NO ONE WILL BE ALLOWED INTO POOL AREA WITH OUT A CURRENT POOL PASS AT ANY TIME. IF PASS IS LOST THERE WILL BE A \$2.00 FEE TO REPLACE – POOL PASSES ARE YOUR RESPONSIBILITY**
- TWO GUESTS ALLOWED FOR OWNER-RESIDENTS ONLY** – OWNER **MUST BE PRESENT** WITH GUEST AT ALL TIMES UNLESS AUTHORIZED BY BOARD.
- RENTER -RESIDENTS** – FAMILY POOL PASS - \$30.00 - THIS IS FOR UP TO 4 FAMILY MEMBERS – 5 MEMBERS AND UP IS \$45.00 - **STUDENT ID'S WILL BE REQUIRED TO PROVE RESIDENCY** – NO GUESTS ARE ALLOWED FOR RENTER RESIDENTS.
- NOT **ADHEREING TO THE RULES SET FORTH FOR THE POOL AREA** WILL RESULT IN BEING REQUESTED BY POOL STAFF TO LEAVE THE POOL AREA. REPEATED OFFENDERS WILL BE BARRED FROM THE POOL
- PROPER SWIM ATTIRE IS REQUIRED** –CLOTHING NOT CONSIDERED SWIM ATTIRE **WILL NOT BE ALLOWED.** NO CUTOFFS / SHORTS/ T SHIRTS ETC..
- NO FOOD ALLOWED IN POOL AREA. - NO GLASS ALLOWED IN POOL AREA**
- NO PETS ALLOWED IN POOL AREA - NO RUNNING IN THE POOL AREA**
- NO ALCOHOLIC BEVERAGES ALLOWED IN THE POOL AREA.**
- NO SMOKING IN THE POOL AREA**
